### SPHERE Database training



We have sent dates for SPHERE database training to all sites that have completed SIVs.

The training is not site specific, so you don't need to co-ordinate availability. Just respond directly to the SPHERE trial office (sphere@trials.bham.ac.uk)

Database training commences 8 August 2024. Sessions are available: 8, 9, 12, 13 August (am and pm) and 14 and 16 August am.

Training must be completed before log-in details are provided. Please book your training ASAP :)

#### What is needed before Greenlight is issued?

✓CVs and GCPs for all staff on the delegation log. CVs must be signed and dated and GCPs current to Trust requirements.

✓ Completed Delegation Log

✓Localisation details for ICF and PIS—Trust header, study team contact details and local PALS

✓Database training

✓Site Initiation Visit

#### Please ensure these are sent to the SPHERE trial office

mNCA must be signed by Trust and University of Birmingham. This is usually dealt with by Trust R&D, but CI and main contact(s) at site will be copied in any correspondence.

#### **Process Evaluation sub study**

SPHERE includes a Process Evaluation sub study (see Protocol for details). This is being carried out by researchers at University College London. Here is a brief summary.

- The sub study applies to RCT participants randomised to the intervention and site staff involved with SPHERE
- The Informed Consent Form for RCT includes an optional clause, which is consent to be contacted about the sub study by a member of the UCL team. If a participant ticks this box, then please complete Contact Details form (online). Details will be passed to UCL team
- Process Evaluation PIS is provided and site staff can give this to participant, so they can read about the sub study
- Discussion about the study and full informed consent will be carried out by UCL researchers
- You or other members of the SPHERE study team at your site may be contacted to see if you would be happy to participate in the study (up to 1 hour interview with UCL researcher)

#### Associate PI Scheme

SPHERE is now registered for the Associate PI Scheme. You will be able to register to be an Associate PI from 15 August 2024.
